NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting **via telephone conference call** pursuant to Texas Government Code, Section 551.125, as amended, and as modified by the temporary suspension of various provisions thereof effective March 16, 2020, by the Governor of Texas in accordance with the Texas Disaster Act of 1975, all as related to the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas. **The telephone conference call phone number is 1-877-304-9269 and the access code is 826495#.** All members of the public may participate in the meeting via telephone conference call.

The meeting will be held on **Tuesday, May 5, 2020, at 12:00 Noon.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Call to order, including explanation of telephone conference call meeting procedures;
2. Public Comments; adoption of Resolution Adopting Public Comment Policies and Procedures;
3. Review and approve the minutes of the March 26, 2020, and April 7, 2020, Board of Directors meetings;
4. Report from Montgomery County Constable's Office regarding the provision of security services within the District;
5. Status of new contract for electricity services for term beginning in 2024;
6. Report by Republic Services of Houston concerning solid waste and recycling collection activities within the District;
7. Consider amendment to Rate Order in connection with annual CPI increase by Republic Services, Inc.;
8. Tax Assessor/Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
9. Report and legal action taken by the District's tax collection attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Operations Report, including:
 - (a) Authorizing the repair and maintenance of District facilities;
 - (b) Appeals of District charges;
 - (c) Referral of accounts for collection and approve write-off of uncollectible accounts;

- (d) Review and discuss list of completed and/or proposed District projects; discuss recommendations from the operator and engineer;
 - (e) Status of Enforcement Action and Agreed Order relative to Montgomery County Municipal Utility District No. 119 ("No. 119") Wastewater Treatment Plant ("WWTP"); and

- (a) Authorizing the design and/or advertisement for bids for construction of facilities within the District, and acceptance of TEC Form 1295;
 - (b) Review and approval of any Storm Water Pollution Prevention Plans related to construction within or on behalf of the District;
 - (c) Authorizing the award of construction contracts or concurrence of award of contracts for the construction and/or repair of facilities within the District;
 - (d) Status of construction and/or repair of facilities to serve land within the District, including the approval of any pay estimates and/or change orders;
 - (e) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
 - (f) Discussion regarding proposed adjustments of sidewalks and status of Interlocal Agreement with Montgomery County in connection therewith;
 - (g) Status of improvements to WWTP by No. 119;
 - (h) Status of Spring Trails Community Association (the "Association") tree installation within certain areas of the District; and
 - (i) Review and approval of proposal for repair of drainage outfall erosion and placement of rip-rap;

 - (b) Adoption of Resolution Nominating Candidate for Appointment to Groundwater Reduction Plan Contract Review Committee of San Jacinto River Authority;
22. Convene in executive session for consultation with attorney pursuant to Open Meetings Act, Section 551.071, Texas Government Code;
23. Reconvene in open session and authorize any necessary action resulting from executive session; and
24. Matters for possible placement on future agendas.
