

MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 94
AMENDED NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting **via telephone conference call** pursuant to Texas Government Code, Section 551.125, as amended, and as modified by the temporary suspension of various provisions thereof effective March 16, 2020, by the Governor of Texas in accordance with the Texas Disaster Act of 1975, all as related to the Governor's proclamation on March 13, 2020, certifying that the COVID-19 pandemic poses an imminent threat of disaster and declaring a state of disaster for all counties in Texas. **The telephone conference call phone number is 1-877-304-9269 and the access code is 826495#.** All members of the public may participate in the meeting via telephone conference call.

The meeting will be held on **Tuesday, July 7, 2020, at 12:00 Noon.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Call to order, including explanation of telephone conference call meeting procedures;
2. Public Comments; adoption of Resolution Adopting Public Comment Policies and Procedures;
3. Review and approve the minutes of the June 2, 2020, Board of Directors meeting;
4. Report from Montgomery County Constable's Office regarding the provision of security services within the District;
5. Approval of audit report for fiscal year ended March 31, 2020;
6. Status of new contract for electricity services for term beginning in 2024; discuss any appropriate adjustments to parameters for contract;
7. Report by Republic Services of Houston concerning solid waste and recycling collection activities within the District;
 - (a) Discuss potential dates for annual document shredding event;
8. Tax Assessor/Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
9. Report and legal action taken by the District's tax collection attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Operations Report, including:
 - (a) Authorizing the repair and maintenance of District facilities;
 - (b) Appeals of District charges;
 - (c) Referral of accounts for collection and approve write-off of uncollectible accounts;

 - (ii) Sinkhole repair by Camino Services;
